Plans are underway by the Missouri Law Enforcement Memorial Foundation for completion of a monument to honor all Missouri law enforcement officers killed in the line of duty since beginning of statehood.

Private donors and sponsoring law enforcement associations and agencies will raise the funds to construct and maintain the Memorial.

The State Historical Society of Missouri will coordinate and compile research material for this worthwhile project. The Society requests that anyone having any information concerning a Missouri law enforcement officer who was killed or died enforcing the law from 1820 to the present, complete the enclosed form. 

COUNTY, MISSOURI

SECOND REUNION Held at Hillsboro, Sept. 1892. President Judge John L. Thomas
Secretary: R. W. McMullin (no records kept)
THIRD REUNION Held at Herculaneum Sept. 1, 1894. President J. M. Bailey,
Secretary: R. W. McMullin (no records kept.)

CONSTITUTION

- I. This organization shall be known by the name of "The Old Settler's Association of Jefferson County, Missouri."
- II. Anyone having attained to the age of fifty years, and having been twenty years a resident of the county, may become a member of this association by giving to the secretary, the name, age and time of resident in this county.
- III. The object of this association is for the purpose of meeting annually, to form new acquaintances, and strengthen old friendships, and preserve the history of the old landmarks, etc. of this county.
- IV. The officers shall consist of a president, vice president and secretary, the latter to serve as treasurer in case any funds accrue; also an executive committee, consisting of one member from each township of the county. The officers are to be elected annually.

Minutes of the 1901 meeting: "out of a membership of 243 enrolled since September 1895, twenty-five have died. Out of the entire enrollment of 263, 157 are entered as native Missourians, 7 are from the Hoosier state, 6 from Ky. 5 from the Buckeye state, 4 from Tenn., 4 from the sucker state, 4 from Penn, 2 from Va. and one each from N.Y. Md., Vt. Ark, and the tarheel state. From foreign lands, Germany takes the lead with 27, England 7, Ireland 3, Scotland 2, Switzerland 1, and Australia 1."
